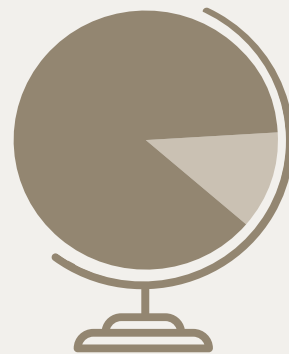

# What Is the LII?

---

The Legal Information Institute (LII) is an independent applied research group housed at Cornell University Law School, whose mission is to help people find and understand the laws that govern them, by:

Since 1992, the LII has provided free, easy access to federal law at [law.cornell.edu](http://law.cornell.edu), the most widely accessed online resource for legal information. With over 500,000 pages of bulk data reformatted into readable and enriched text, supported by new technologies to improve access and objective contextual analysis to facilitate comprehension, the LII goes far beyond what official government sources currently offer, resulting in a yearly average of 33 million unique visits to the site from around the world.

LII readership includes lawyers, government employees, businesspeople, students, and average citizens. Even individuals with access to an official source or a fee-based service regularly prefer the LII's user experience.

### (a) REGULATIONS

(1) The admission to the United States of any alien as a nonimmigrant shall be for such time and under such conditions as the Attorney General may by regulations prescribe, including when he deems necessary the giving of a bond with sufficient surety in such sum and containing such conditions as the Attorney General shall prescribe, to insure that at the expiration of such time or upon failure to maintain the status under which he was admitted, or to maintain any status subsequently acquired under section 1258 of this title, such alien will depart from the United States. No alien admitted to Guam or the Commonwealth of the Northern Mariana Islands without a visa pursuant to section 1182(f) of this title may be authorized to enter or stay in the United States other than in Guam or the Commonwealth of the Northern Mariana Islands or to remain in Guam or the Commonwealth of the Northern Mariana Islands for a period exceeding 45 days from date of admission to Guam or the Commonwealth of the Northern Mariana Islands. No alien admitted to the United States without a visa pursuant to section 1187 of this title may be authorized to remain in the United States as a nonimmigrant visitor for a period exceeding 90 days from the date of admission.

### (2)

(A) The period of authorized status as a nonimmigrant described in section 1101(a)(15)(O) of this title shall be for such period as the Attorney General may specify in order to provide for the event (or events) for which the nonimmigrant is admitted.

(B) The period of authorized status as a nonimmigrant described in section 1101(a)(15)(P) of this title shall be for such period as the Attorney General may specify in order to provide for the competition, event, or performance for which the nonimmigrant is admitted. In the case of nonimmigrants admitted as individual athletes under section 1101(a)(15)(P) of this title, the period of authorized status may be for an initial period (not to exceed 5 years) during which the nonimmigrant will perform as an athlete and such period may be extended by the Attorney General for an additional period of up to 5 years.
